1.	Students are responsible for all information on the MBHS parking page found at the <u>website</u> .
2.	All vehicles must be registered through the school office and the decal must be permanently affixed to
	the lower corner of the passenger windshield. If a student desires to drive multiple vehicles during
	the school year, a permit must be purchased for each vehicle.
3.	If a student desires to change vehicles mid-year (ex. purchase a new vehicle), he/she must register the
	new vehicle online, bring the remnants of the old decal to C202, and pay a \$10 replacement fee.
4.	In the case of a lost/stolen parking decal, students are responsible to pay the full price of a new permit.
5.	Vehicles, including motorcycles, must be parked in the student designated parking area. Any vehicle
	parked out of location, will be booted (you are <b>NOT</b> subject to receiving a warning, you may be booted
	first time). The boot removal fee is \$30.00. See MBHS parking website for details.
6.	Students may not go to their vehicles during school without written permission from the school office.
<u> </u>	Students may not loiter in their vehicles before or after school.
8.	Students must drive no faster than 10 MPH through the campus.
9.	Students are held responsible for prohibited objects in their vehicle such as but not limited to tobacco,
	alcohol, drugs/medication of any kind, weapons, and shotgun shells/ bullets.
10	. SEARCH AND SEIZURE: Permission to park on the MBHS campus is granted subject to all rules and
	regulations of the school. By entering the parking lot, the person driving any vehicle is giving consent to
	complete search of the vehicle by the school officials or police. If any person in the car other than the
	driver is the current custodian of the vehicle, consent to search is deemed given by the custodian also. The
